

# FALL 2025 FLIGHT LAB DEADLINES

## **August 10 – Summer 2025 Grades Due**

- We will begin evaluating GPAs to see if awarded students are eligible to retain an awarded Fall 2025 flight lab.

## **August 17 – Fall 2025 Registration and Retention Deadline**

- All remaining requirements and documents must be submitted to [FlightLab@mtsu.edu](mailto:FlightLab@mtsu.edu) in order to retain flight lab by the end of this day or they will lose their lab.
- All students must obtain any prerequisite pilot certificate or rating for their respective flight lab by the end of this day or they will lose their lab.
- Students must also be registered for the lab and all co-requisite courses by the end of this day or they will lose their lab slot.
- International students in labs that require TSA approval must be granted "Final Approval" from the Flight Training Security Program (FTSP) by the end of this day or they will lose their lab slot.

## **August 22 – Flight Account Fully Funded**

- All students must have all flight lab fees deposited into flight account by 4:30 pm on this day or have received a waiver from [FlightLab@mtsu.edu](mailto:FlightLab@mtsu.edu) or lab will be rescinded.

## **August 25 – First Day of Fall 2025 Flight Labs**

- All Spring and Summer 2025 incomplete students who resume training for the fall semester will be held to the attendance policy and will be required to meet with their instructor accordingly until FAA checkride is complete.

## **August 28– Fall Semester Launch**

- All students and instructors will be required to attend the Fall Semester Launch. Please do not skip any classes for this. The meeting will be held in LRC 221 from 6 pm – 8 pm.

## **September 2 – First Week Requirements Deadline**

- All requirements listed in the *Flight Lab Guide* must be met by the end of this day. This includes presenting TSA documentation to your flight instructor, completing first-day paperwork, and purchasing your required materials.

## **September 15 – Spring 2026 Flight Lab Request Forms Open**

- Submit your form electronically. Request forms can be accessed via a link on the MTSU Aerospace website.
- All uploaded files must be submitted in JPEG or PDF format.
- Be sure to follow all instructions carefully. Any errors in your submission may hinder your chance for a flight lab.
- Students will receive an automated response verifying receipt but are strongly encouraged to save a copy for future reference.

## **October 15 – Plane English Mid-Semester Deadline**

- Stages 1 and 2 of the Plane English modules must be completed by 11:59 pm on this day for all newly enrolled Private and Instrument students. The student will receive an absence for each stage not completed.

## **October 23 – Mid-Semester Student Briefing**

- All students will be required to attend the Mid-Semester Student Briefing. Please do not skip any class for this. The meeting will be held in LRC 221 from 6 pm – 9 pm.

## **November 15 – Spring 2026 Flight Lab Request Forms Due**

- Any request submitted after this date will be considered late. Late applications may be considered after all eligible and on-time submissions.

## **December 5 – Plane English Semester End Deadline**

- Stages 3 and 4 of the Plane English modules must be completed by 11:59 pm on this day for all newly enrolled Private and Instrument students. The student will receive an absence for each stage not completed. All previously incomplete stages must also be completed by this date.

## **December 5 – Last Day of Fall 2025 Flight Labs**

- If you are a prior semester incomplete student, you must have completed your checkride by this date or you will receive an "F" for the course.
- Checkrides may not be scheduled for prior incomplete students after this date.

## **December 14 – Fall 2025 Grades Due**

- We will begin evaluating your GPA to see if awarded student is eligible to retain an awarded Spring 2026 flight lab.

## **December 18 – Spring 2026 Flight Lab Awards Announced**

- Students will be notified by email of their lab award status.
- Read entire email carefully and complete any necessary steps before the deadlines noted in the award email. Not completing the necessary steps outlined in the award email may result in your awarded lab being rescinded.

## **December 19 – January 1 – MTSU FEC Closed for the Holidays**

- The flight school will close at 6pm on December 18th and reopen at 8am on January 2nd. No grounds, SIMs, flights, or checkrides allowed during this time.

## **January 12 – Spring 2026 Registration and Retention Deadline**
